Geaffekteerde kliënte word versoek om die vereiste dokumentasie gedurende normale werksure of deur die amptelike munisipale kontakkanale by die Munisipale Inkomstekantoor in te dien.

Versuim om die vereiste dokumentasie in te dien, kan lei tot vertraging in die opdatering van munisipale rekords en kan die administrasie van munisipale dienste wat met die eiendom verband hou, beïnvloed.

Die Munisipaliteit waardeer die samewerking van inwoners en betuig sy meegevoel aan die geaffekteerde families.

PUBLIC NOTICE: SUBMISSION OF DEATH CERTIFICATES FOR DECEASED PROPERTY OWNERS

- Facilitate the lawful management of municipal services linked to the property.

Affected customers are requested to submit the required documentation to the **Municipal Revenue Office** during normal working hours or through the official municipal contact channels.

Failure to submit the required documentation may result in delays in updating municipal records and may affect the administration of municipal services linked to the property.
